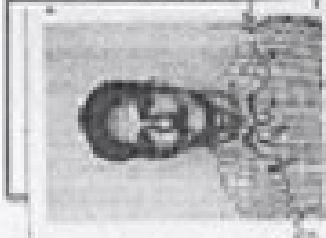



**D) Vacancy: -**
